1.0 DESCRIPTION

The Tronair Model 01-0571-0011 Multi-Head is a towbar head attachment for the Bombardier CRJ 100 and CRJ 200 and the Hawker Horizon aircraft.

The towbar head attachment is designed for use with Tronair Multi-Head Towbar Models 01-1201-0010, 01-1202-0000, 01-1215-0000, 01-1216-0000 and 01-1290-0100 for towing the previously stated aircraft. The towbar head attachments use sliding pins to interface with the aircraft tow point.

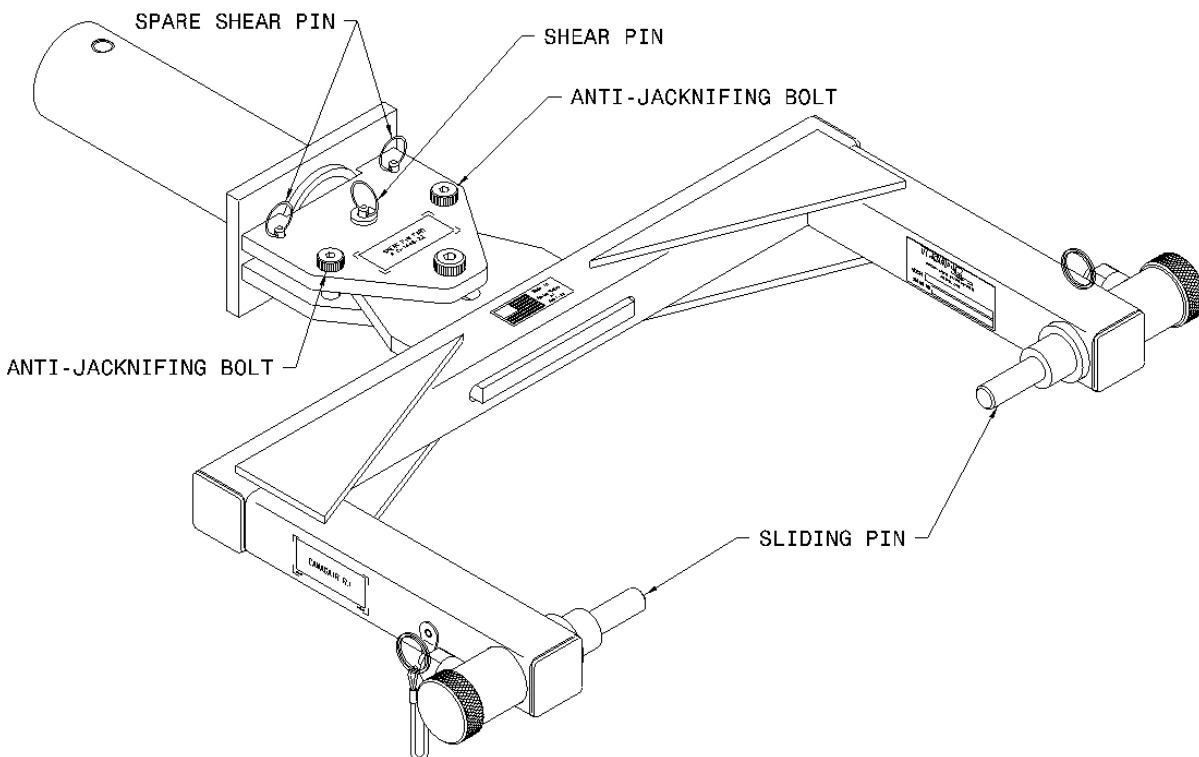

2.0 SAFETY INFORMATION

2.1 GENERAL

The Tronair Model 01-0571-0011 towbar head attachment is used for towing Bombardier CRJ 100 and CRJ 200 AND Hawker Horizon aircraft only.

To ensure safe operation, please read the following statements and understand their meaning. This manual contains safety precautions which are explained as follows. Please read carefully.



WARNING! Warning is used to indicate the presence of a hazard that can cause **severe personal injury, death, and/or substantial property damage** if the Warning notice is ignored.

CAUTION! Caution is used to indicate the presence of a hazard which will or can cause **minor personal injury or property damage** if the Caution notice is ignored.

3.0 OPERATION



WARNING!

A damaged or bent towbar should not be used. Towbar should be repaired or replaced.

WARNING!



Tronair recommends the use of a towbar with a category 1 or category 2 tug and aircraft not exceeding 75,000 lbs gross weight. Using the towbar with aircraft weighing in excess of this specific limitation may result in excessive loads and stresses being applied to the towbar and/or the aircraft. These excessive loads may cause failure of the towbar which could cause damage (INCLUDING WITHOUT LIMITATION to the aircraft) and/or personal injury OR DEATH. TRONAIR MAKES NO REPRESENTATION, WARRANTY OR GUARANTEE AS TO SUCH MISUSE AND DISCLAIMS ANY AND ALL LIABILITY FOR INJURY, LOSS OR DAMAGE ARISING FROM OR RELATING TO SUCH MISUSE.

3.1 MAINTENANCE CHECKLIST

- Inspect all welds for cracks. If any weld cracks are found, remove towbar head from service and contact Tronair for repair.
- Inspect shear pin. Ensure that the shear pin is not bent, broken, or missing. Replace the shear pin if required. Only use the Tronair specified shear pin.



WARNING!

Damage to the aircraft can occur if it is towed without shear protection.

- Inspect the sliding pins for bending, cracks, and wear. Do not use a sliding pin that is bent, cracked or excessively worn. Contact Tronair for replacement.
- Verify that sliding pins can move freely within their housing. If any binding occurs, inspect the sliding pin for bending and the housing for roundness. If either of these situations are present, contact Tronair for repair options.
- Check the sliding pin retaining pin assemblies. Ensure that they positively lock the sliding pins into position. If they do not, contact Tronair for repairs.
- Check the shoulder bolt connections through the shear plates. Verify that they are NOT clamping the shear plates together. There should not be any clamping force applied to the shear plates so the assembly functions properly.
- Inspect the shear plates for bending. If any bending has occurred, remove towbar head from service and contact Tronair for repair.
- Inspect the head and side rails for bending. If bending has occurred, contact Tronair for repair.
- Inspect the head plate for bending. If bending has occurred, contact Tronair for repairs.
- Inspect the shear pin bushings for cracking or chipping. If the bushings have cracks or chips, contact Tronair for replacement. Only use Tronair specified shear pin bushings

3.2 Usage Procedure

Secure the towbar head attachment using the ball lok-T pin (supplied with the multi-head towbar) onto one of the following Tronair Multi-Head Towbar Models:

- 01-1201-0010
- 01-1202-0000
- 01-1290-0100
- 01-1215-0000
- 01-1216-0000

4.0 TRAINING

4.1 Training Requirements

The employer of the operator is responsible for providing a training program sufficient for the safe operation of the towbar.

4.2 Training Program

The employer-provided operator training program should cover safety procedures concerning use of the towbar in and around the aircraft at the servicing location.

4.3 Operator Training

The operator training should provide the required training for safe operation of towbar.

NOTE: Maintenance and Trouble Shooting are to be performed by the skilled and trained technician.

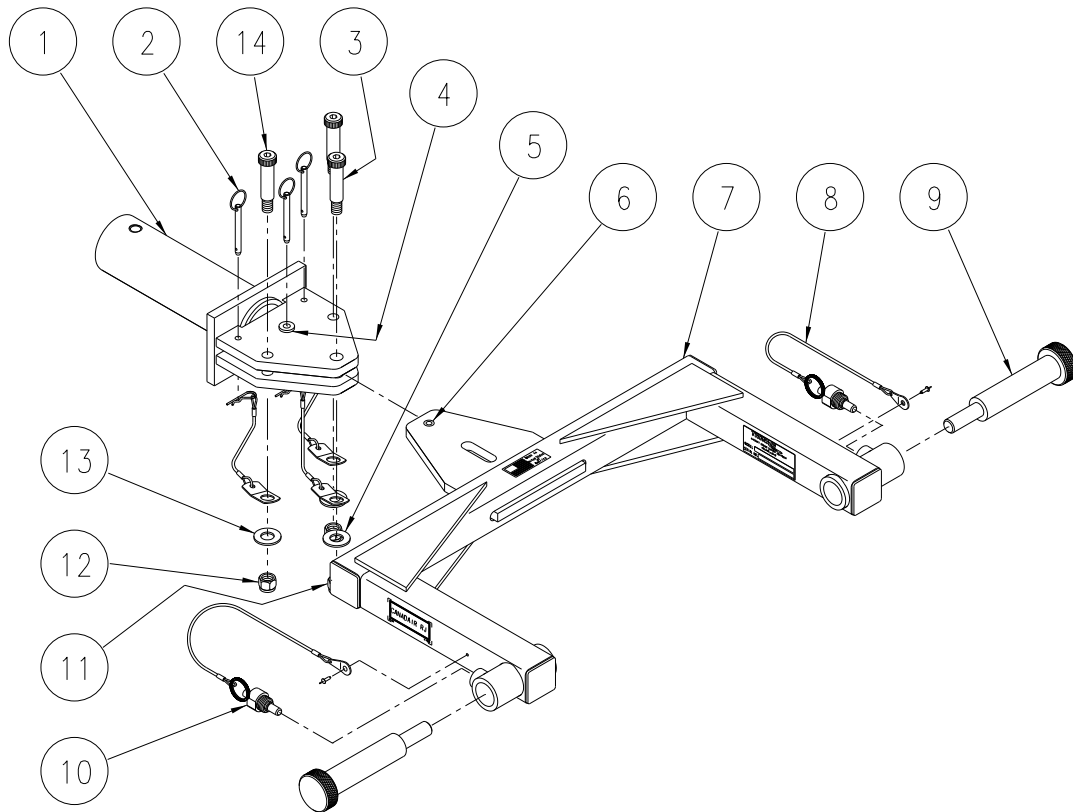
- a) Product Model Number

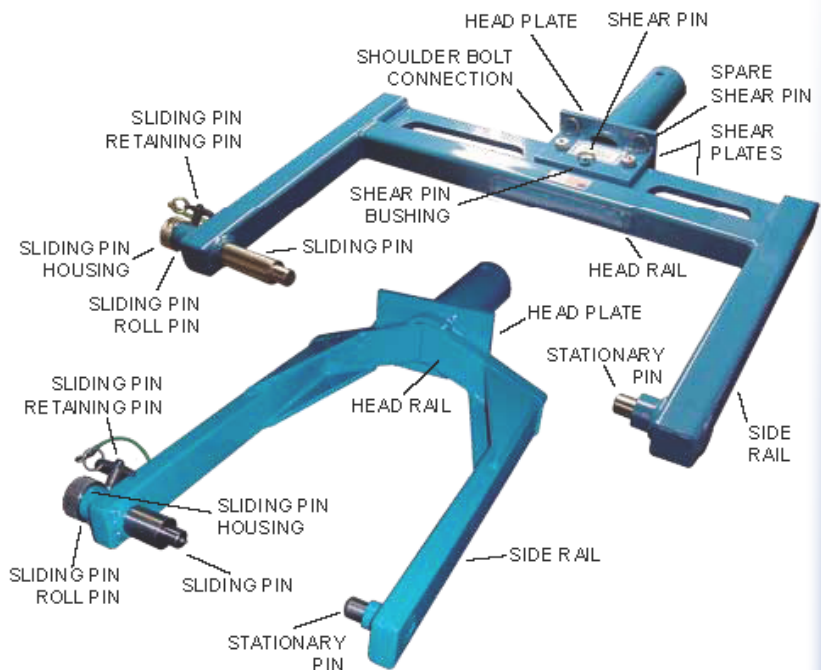

Tronair recommends towbar inspections at least once a week.

- Inspect for weld cracks. If found remove the towbar multi-head from service and contact Tronair for repair.
- Inspect the side rails, head rail, and head plate for bending. If found remove the towbar multi-head from service and contact Tronair for repair.
- For towbar multi-heads with shear, inspect the shear plates for bending. If found remove the towbar multi-head from service and contact Tronair for repair.
- Inspect the sliding pin(s) and (if applicable) the stationary pin for bending, cracks, and excessive wear. If found remove the towbar multi-head from service and contact Tronair or your Tronair distributor for replacement.
- Ensure the sliding pin(s) can move freely within its housing. If any binding occurs, inspect the sliding pin for bending and the housing for out-of-roundness. If either condition exists, contact Tronair for repair options.
- Inspect the sliding pin retaining pin assembly. Ensure the retaining pin is not missing. Ensure the retaining pin can engage the sliding pin through its housing and that it positively locks the sliding pin into place. If it does not, contact Tronair or your Tronair distributor for replacement/repair.
- Verify the sliding pin is secure to the towbar multi-head via its lanyard. Replace the lanyard if missing.
- Inspect the sliding pin roll pin (located through the sliding pin housing). Ensure the sliding pin roll pin is not loose or missing, contact Tronair or your Tronair distributor for replacement if needed.
- For towbar multi-heads with shear, check the shoulder bolt connections through the shear plates. Verify they are not clamping the shear plates together. There should not be any clamping force applied to the shear plates so the assembly functions properly. If required, back the stopnut off to remove any clamping force applied.
- For towbar multi-heads with shear, inspect the shear pin. If the shear pin is bent, broken, or missing contact Tronair or your Tronair distributor for replacement. Tronair recommends purchasing spare shear pins for rapid replacement, use only Tronair specified shear pins.
- For towbar multi-heads with shear, inspect the shear pin bushings. If the shear pin bushings are cracked or chipped, contact Tronair or your Tronair distributor for replacement, use only Tronair specified shear pin bushings.
- Inspect all steel components for signs of rust. Touch up with paint as required.
